Consultation on the Draft Admissions Policy 2023/24

Admissions authorities are required to consult on their admission arrangements whenever a change to the arrangements are proposed, or if no changes are proposed, every 7 years. As such the Cabot Learning Federation is consulting on the admissions arrangements for the academies shown below, for students joining from September 2023.

Academies in **Bristol** – consultation period 15th November 2021 - 11th January 2022

- Summerhill Academy

The academy is amending its policy to make clear that Summerhill Infant School is a feeder school for Summerhill Academy

Academies in **South Gloucestershire** – consultation period 15th November 2021 – 11th January 2022

- King's Oak Academy

The all-through academy is amending its policy to make clear that the external PAN for Year 7 is 90 places due to 60 places being reserved for those students already on roll in Year 6.

- Post 16

Post 16 is amending its policy to make clear the admissions process for students already on roll at John Cabot Academy and for those attending Year 11 at other CLF academies.

Academies in **North Somerset**

- Herons' Moor Academy – consultation period 15th November 2021 - 11th January 2022

The academy is amending its policy to remove from the oversubscription criteria the priority for children of staff at Herons' Moor Academy, and the removal of priority, under the sibling rule, for students with a sibling that has recently left Year 6.

- Winterstoke Hundred Academy – consultation period 13th December 2021 – 25th January 2022

The Cabot Learning Federation (CLF) is due to open an additional site for Winterstoke Hundred Academy in the 2023/2024 school year (subject to the site being handed over to the school in August 2023). The admissions policy has been updated to reflect that there will be two addresses for Winterstoke Hundred Academy for admissions purposes: one for Years 7 to 11 and one for Post 16 provision (Years 12 to 13).
